	No training has been attended since the last meeting.	
10.	Extra-Curricular Items	
	JB raised that it was identified through Governor Awareness Day in February , following discussions with staff regarding music and arts, that the School Choir is running really well but that there is no longer a School Orchestra or Recorder Group.  SV responded that there is no orchestra at present as there have not been enough children playing instruments to run an orchestra. Vanessa Tyrell does private paying music lessons in school.  JB asked what is being done for all children in school regarding music? SV confirmed that the requirements of the curriculum are being met.  JB asked if there is anyone who could run a recorder club? SV advised not at present that he is aware of. Vanessa was paid by the school for running the orchestra and would need to be paid for whatever club she was approached to do.
